Please note the following:

- You must supply your own table (Max: 4' X 8') and chairs.
- Cherry Fiesta venues **MUST** be set up between the hours of 7:00 a.m. and 10:00 a.m. BEFORE the Parade. No vehicles are allowed IN or OUT of Gyro Park between 10:00 a.m. and 1:00 p.m.
- Food vendors must attach an Interior Health Permit form for July 1st, 2017.
- All vendors must provide proof of Liability Insurance.
- No power will be available. You must supply your own generator.
- Venues must be packed up and vacated before 10:00 p.m. unless special permission is granted.
